Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/2014 dated 19.05.2014, referred 05(five) posts(OM-02 RBA-02 ST-01) of Assistant Professor in the discipline of Punjabi to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014, and
