Whereas, the J&K Services Selection Board vide communication No. 558/Secy/56/2015/16461-64 dated 21-12-2015 forwarded selection list of 78 candidates for the posts of Junior Assistants (Divisional Cadre Kashmir/Jammu) advertised vide Advertisement Notice No.86 of 2013 dated 10-5-2013 alongwith waiting list of 18 candidates in Open Merit; and

2. Whereas, the formal appointment orders were issued by Finance Department vide Government Order No. 17-F of 2016 dated 19-01-2016, G.O. No. 40-F of 2016 dated 01-03-2016, G.O.
