Subject:- Written test for the post of Assistant Legal Remembrancer/Public Law Officer notified vide Notification No. 03-PSC(DR-P) of 2018 dated 29.01.2018.

Notice Dated: 21.05.2018

Whereas Law, Justice and Parliamentary Affairs Department, Jammu and Kashmir Government vide No. LD(Estt) dated 03.01.2018 referred 23 posts of ALR/PLOs for selection by Jammu & Kashmir Public Service Commission (PSC) without reference to horizontal reservation viz the posts referred and;

2) Whereas the PSC vide Notification No. 03 PSC of 2018 dated 29.01.2018 invited applications for the posts referred to and;

3) Whereas the last date for receipt of application was 28.02.2018 and;

4) Whereas the JKPSC is scheduled to conduct written test for the posts mentioned above on 27.05.2018 for which all necessary arrangements are in place and;

5) Whereas the Hon'ble High Court, J&K (Jammu Wing) in SWP No. 926/2018, MP No. 01/2018 titled Suraj Singh Vs State & Ors has been pleased to pass the orders dated 16.05.2018 an excerpt thereof is reproduced below:-

"Extension of the last date for receipt of the application from the candidates falling under physically challenged category by minimum of five days from the date the decision is so taken so that not only the petitioner but even other similarly situate in the said category can get the requisite benefit. The notification, which PSC might issue, should specifically states that candidates in the physically challenged category can apply."

6) Whereas in compliance with the aforesaid decision of the Hon'ble High Court the matter was taken up with the Department of Law, Justice and Parliamentary Affairs, being the cadre controlling authority, for clarification with regard to horizontal reservation available under rules for physically challenged category, the reply thereto is awaited and; 7) Whereas the Hon'ble High Court in the judgement has fixed timeline, therefore, in compliance with the judgement and pending reply/clarification from the Law Department, it is ordered as under:-

- i. The application(s) on the format as per Annexure A to this Notice alongwith the requisite documents and prescribed fee of Rs.800/= for Open Merit candidates, Rs.400/= for the candidates belonging to RBA/SC/ST/ALC/SLC categories, in the shape of demand draft on the name of Controller of Examination, J&K PSC, payable at Jammu/Srinagar, shall be submitted by eligible candidates falling in physically challenged category including by the petitioner within a period of 5 days to be reckoned from 21.05.2018 provided he/they were otherwise eligible on the cut off date i.e 28.02.2018;
- ii. The candidature of such of the candidates as may file/submit applications in response to this Notice shall be provisional unless Department of Law, Justice and Parliamentary Affairs, as cadre controlling authority, specifies the availability of horizontal reservation in the cadre which is normally provided one each at 33, 66 and 99;
- iii. The admit cards of the candidates shall be issued as soon as the application forms on the prescribed format are received in the Commission either online on jkpsc.nic.in or hard copies submitted in the JKPSC office, Solina, Srinagar/Camp office, Resham Garh, Bakshi Nagar, Jammu.
