**SUB:-Deficiency of Documents of the candidates for Hiring of contractual staff under NHM for the year 2020-21 in District Samba**

Whereas, the Vice Chairperson District Health Society, Samba after approval from Chairperson District Health Society (District Development Commissioner), Samba vide Advertisement Notification No. 01 of 2020 dated:- 22.09.2020 invited applications on prescribed format from the permanent residents of District Samba for hiring of contractual staff under NHM for the year 2020-21 in District Samba.

Whereas, in response to the above notification, the Society received a total of 334 applications for various categories of posts advertised.
